## **Another Sale By SFL**

SFL has sold the "Ilot Sébastopol" property at 91-103 Boulevard de Sébastopol, Paris 2, to RREEF, a property investment fund, and DTZ Asset Management for €51.5 million excluding transfer costs.

The Haussmann-style property, strategically located in the heart of Paris, comprises some 11,700 square metres of retail, office and residential units. Home to the Monoprix department store, it represents annual rental revenue of some €2.4 million.
